“Immunization, Inoculation or Vaccination; Navigating the Consequences with Clinical Nutrition” **We will be Exploring Options for Helping Children and Adults Recover from Medicine Related Adverse Events.**

Children and adults who have sustained documented immunological, gastrointestinal, and neurological disruptions from simultaneous toxic exposures from medications, environmental influences, vaccinations, etc. are often ignored or misdiagnosed. As Clinical Nutritionists, what can we do to help?

When prescribing medications pharmacogenetically, factors are considered such as age of the patient, timing of exposure, genetic polymorphisms for detoxification, metabolic individuality, breastfeeding history, usage of antibiotics or other drugs, or co-morbid conditions such as allergies, asthma, or GERD before they are dosed. When they are not, the risk of side effects and suffering is greater. Today, this is the direction of individualized medicine. This should also be the standard for Board Certified Clinical Nutritionists who can be instrumental in supporting metabolic and detoxification pathways, remediating the consequences, and improving the lives of those people who have reactions to these accidental toxins. We, too, are obligated to do no harm while doing our best to facilitate the healing process for our patients who react aberrantly to simultaneous toxic exposures.
